Additional Work	We have set out in detail the deliverables that we consider will be required, based on our experience, to deliver your Project to
	the high standard that Ideaworks espouses. Nevertheless, every client is different. Should you require us to undertake additional work in order to support the design of a scheme that meets your requirements, we will be happy to do so. All additional work will be billed in accordance with our Global Terms & Conditions.
CDM Regulations	We have prepared this Fee Proposal on the assumption that we shall be carrying out the duties of a designer (not the Principal Designer) under the Construction (Design and Management) Regulations 2015 (SI 2015/51) (the 'CDM Regulations') and that the duties of Principal Designer shall be carried out by Others. Under the CDM Regulations, the Client must make suitable arrangements for managing a project to ensure that construction work can be carried out, so far as reasonably practicable, without risks to the health and safety of any person affected by the project. This applies to domestic/consumer clients as well as those operating the course of a business. We would be happy to introduce the Client to a suitably-qualified CDM consultant to undertake the relevant assessments, advise on the Project, and discharge this duty on the Client's behalf, including the preparation of the Construction Phase Plan and the provision and maintenance of the Health and Safety File.
Construction Procurement	We have assumed that if we are appointed to deliver the designed schemes that we will be appointed directly by you, the Client, and made available free-issue to the Main Contractor or Shipyard as appropriate. Where you ask us to enter into a contract with a Main Contractor or Shipyard, we have assumed that they will appoint us on our Global Terms & Conditions.
Devices	Our engineers rely on internet-enabled devices to be able to access our systems and servers for the execution of the Services and delivery of the Works. We have assumed that an internet connection or cellular network of 4G standard or higher will be available on site.
Digital Files	We use Autocad and a proprietary software able to output PDF and can provide our files in this format. Should our drawings be required in an alternative format for third party consultants, we will be happy to provide a quote for their conversion. Our standard provision of digital files is as PDF files. Should the client require ArchiCAD or DWG files, these will be provided on the basis that the PDF file format takes precedence and Ideaworks does not accept any liability for any loss or damage arising out of the use of information provided in any other format.
Electronic Document Control	This Fee Proposal assumes that no electronic document control system is to be implemented (such as BIW or FusionLive). Any additional costs incurred by Ideaworks (including but not limited to any additional time required to use and/or administer such systems) shall be charged as Additional Services and any licence costs for the same shall be charged as Expenses.
Excluded Services	Unless they have been listed specifically as deliverables under a work stage contained within this Fee Proposal, no other services are included within the scope of our appointment. We are able to assist in the provision of the same, upon request, on the time basis set out in the Schedule of Fees and Expenses, some examples of which might include:
	- Procurement routes other than single-stage tender for the building works, or the negotiation of a price with a single contractor or Shipyard;
	- Services in any dispute between the Client and another party;
	- Value engineering;
	- Services following damage by fire and other causes;
	- Services following suspension or termination of any contract or agreement with a contractor or Shipyard;
	- Services in connection with government or other grants; or
	- Specialist services in relation to historic buildings and/or conservation works.
Expenses	Please see our Schedule of rates.
Fee Proposal	This Fee Proposal is valid for 3 calendar months from the date set out at the beginning.
Long-Term / Suspended Projects	Occasionally, projects are placed on hold by clients; or issues arise relating to the Site, Shipyard, planning, or other circumstances that cause them to be suspended or delayed. The Client hereby agrees that Ideaworks shall be entitled to increase the fees quoted in this proposal in accordance with the Ideaworks Global Terms & Conditions for any incomplete work in relation to the Project.

Matrix of Responsibilities	Ideaworks shall coordinate and integrate the overall design, including input from the Client's other consultants and specialist suppliers and sub-contractors. In respect of Mechanical & Electrical Services, however, the relationship between those services is to be co-ordinated by the Mechanical & Electrical Engineer. In any event, Ideaworks shall solely be responsible for those matters set out in the below Matrix of Responsibilities as being Ideaworks' responsibility.
Photography	We rely on photography from our projects to support our new business development and marketing activity as a business. The fees set out above reflect a subsidised amount, taking account of the enormous value to us of being able to use anonymised photographs of your scheme as it develops to help us continue to grow and thrive. If, nevertheless, you would prefer not to have any photographs taken of your property and shared, even anonymously, please let us know and we will revise the fee accordingly. Notwithstanding any contrary agreement relating to photography for marketing purposes, we require the ability to take and store photographs of technical details and installations for our own quality assurance, insurance, after-care and warranty purposes.
Revisions to Drawings	We allow for one round of integration drawing reviews, followed by sign-off after our information has been incorporated. If we are required to provide further rounds of reviews and/or sign-offs, or any further revisions, these will be charged as Additional Services.
Samples	Please note that all samples must be returned to us. Many of these remain property of our own suppliers. We reserve the right to charge a fee for the replacement of any samples that you do not return to us upon request.
Site Meetings	Unless otherwise set out in the Quotation, we have allowed for a mix of on-site and remote (video) meetings. Unless a meeting cannot, in our discretion, reasonably be dealt with effectively via video, we have assumed that it will take place via video. If our attendance in person is nevertheless required, the same shall be considered Additional Services and charged for accordingly.
Sub-Consultants	No allowance has been included in our fee for any management of or attendance on sub-consultants (including but not limited to Security, lighting, spa, gym, swimming pool, landscape or other specialists). Should the Client wish for us to appoint designers as sub-consultants under our scope of services, a management and attendance fee of 15% of the sub-consultants' fees shall be levied to cover the time required to brief, negotiate with, appoint, supervise, attend upon and co-ordinate with those sub-consultants and to include their works within the scope of our liability and any warranty.
Terms	Subject to Ideaworks' Global Terms & Conditions (the 'Ideaworks Terms') supplied to you with this Fee Proposal. The Ideaworks Terms shall operate to the exclusion of all terms advanced by you, which shall be of no effect.
Travel	The fees detailed above include all travel within the M25. Any travel outside of the M25 will be billed to the client at cost as an expense pursuant to our Schedule of Fees and Expenses.

To ensure the smooth transition between trades there needs to be clear areas of responsibility. These are shown in the below schedules for the various elements of works that Ideaworks may be contracted to provide. Ideaworks will always endeavour to help in the smooth running of the project and give appropriate guidance to other trades. The General guidelines are common to all disciplines.

Specification and supply of control cabling	•				
The contractor should allow to purchase and install the relevant amount of cable. See Ideaworks specification sheet. Requests for cables should be made a minimum of two weeks before delivery is required.		•			
All cabling should be installed and clearly labelled as per Ideaworks drawings.		•			
Any specialist cabling supplied by the contractor not purchased from Ideaworks will need to be approved by Ideaworks prior to installation. Ideaworks require a 4 week period for test.		•			
All back boxes must be installed flush to finished surface. The finished surface must also be brought up to the edge of the back box as the insert plates have a minimal overhang.		•			
Adequate provision for heat, fire or smoke detection to technical spaces should be made			•		
All ELV cables must be run separate to the 240v feeds. Ideaworks recommend 300mm separation although this should be wired in accordance to BS7671 or any superseded standard.		•			
For efficient PoE deployments, data cable bundle sizes should be limited—and bundles should not be stacked or packed tightly. As a simple rule of thumb, we recommend that bundle sizes be limited to a maximum of 24 cables per bundle. Tables in the appropriate TIA, ISO/IEC and CENELEC cabling standards on remote powering implementation provide a mechanism to check if a particular cable category bundle size is acceptable.		•			
Cables should not be crushed or the recommended bend radius exceeded. The use of cables ties as sole support must be avoided.		•			
Location, sizing, routes and supply of containment, including surface trunking to lighting racks and AV Headend		•			
Mounting of lighting racks, AV headends, wall mounted enclosures or panels		•			
Cabling and equipment should be protected from water damage, ie placement of FCU drip trays			•		
Equipment should not be moved or tampered with without prior written consent from Ideaworks			•		
All equipment should be protected from dust and damage one installed			•		
A safe storage area should be provided for all equipment delivered to site			•		
Providing an up-to-date master program that incorporates the works and timelines of all trades			•		
Provision of any scaffold or access equipment as required with safe working conditions.			•

Free access to all areas requiring works to be carried out must be confirmed prior to installation.			•
